

AL UDEID AIR BASE (AUAB) AND CAMP AS SAYLIYAH (CAS) QUARANTINE INFORMATION

WHO WILL BE QUARANTINED?

1. All personnel arriving at AUAB whose **Point of Embarkation is Baltimore or Norfolk** will be placed in a 14-day quarantine upon arrival at AUAB. **Quarantine request forms are NO LONGER required.**
2. All personnel arriving at AUAB whose **Point of Embarkation is from one of the ten (10) approved Department of the Air Force Aggregation Installations** will not need to quarantine at AUAB as long as all requirements have been met and no members have interacted with any personnel outside their cohort for the entirety of their time from quarantine to arrival at AUAB. Members **MUST** maintain their Wing Commander signed Pre-Travel Quarantine Certification on their person.
 - a. Travelers continuing to other locations in the AOR will be placed in clean transient town until departure.
 - b. Those remaining at AUAB will be released to their units.
3. All personnel arriving at AUAB in a **transient status** will be sequestered and given a restriction of movement order until they depart AUAB.
4. **Transient aircrew** who immigrate into Qatar will be sequestered and given a restriction of movement order until they depart AUAB.
5. All **intra-theater travel personnel** arriving at AUAB with a signed AFCENT COVID-19 Certificate of Medical Examination signed within 24 hours of travel to AUAB may be released to the general population as long as member is asymptomatic.
6. All **contractors** must be assigned to a Unit Line Number (ULN) built by their respective component. All contractors must have a valid Qatar visa PRIOR to departure from US. All contractors must comply with theater entry requirements, foreign clearance guide, and USCENCOM entry instructions. 7. All **military, civilian, and contractors assigned to US Forces-Afghanistan (USFOR-A)** must contact the USFOR-A Liaison at DSN 318-436-7368.

WHEN YOU ARRIVE

**** Members should contact their sponsor/unit prior to arriving at AUAB so they are aware of arrival time/date. ****

- Members who must quarantine will be bussed directly to Quarantine Town (Q-town) at AUAB or CAS. Capacity at AUAB at the time of arrival will determine the quarantine location for arrivals.
- Members must be prepared for the 14-day quarantine upon arrival. There will be no stops between immigrations and Q-Town.

DURING YOUR STAY IN QUARANTINE

- Members will be assigned to a **cohort** – a group individuals who arrived within 48 hours of each other. Cohorts are designed to prevent cross-contamination and prevent the potential spread of COVID-19.
- Cohorts will be assigned specific bathroom facilities, DFAC times, and laundry days.
- **All members are required to wear a cloth face mask when entering any shared space or when they are unable to maintain 6 feet of distance from another person.**
- Quarantined members are required to complete **two temperature checks daily** for 14 days.
- **Quarantined members are prohibited from physically interacting with non-quarantined members.**
- Units are encouraged to communicate with their members while in quarantine via text message or email and can drop off supplies to the Quarantine staff in the Quarantine Admin Building (RLB 30200) DSN# 455-6165.
- AAFES comes to Q-Town three days a week to provide limited items for sale. AAFES accepts cash as well as Eagle Cash Cards in Q-Town. Eagle Cash Cards are issued on-site to U.S. forces only.
